It shall remain open to Audit by authorized Auditors and for inspection by the officers of this Department as well as test check by the Accountant General, Odisha, Bhubaneswar or any other agency authorized by the Government for the purpose.
4. No Utilization Certificate is required under this Grant but MIS shall be furnished by the Block Development Officers concerned Nabarangpur.
