Specific Terms and Conditions:

1. The DDO-cum-Joint Secretary, PR & DW Department is hereby declared as Drawing and Disbursing Officer. The bill is to be drawn at Special Treasury -II, OLA Campus, Bhubaneswar and to be credited to the concerned Zilla Parishad PL Accounts in Scheme ID-01(non-specified scheme) as per the list enclosed at Annexure-'A'.
2. The utilization of fund is subject to the following terms & conditions.
 - (i) The funds shall be utilized as per PR&DW Department guideline issued vide letter No.2254/dt.03.02.2023.
 - (ii) The detail account of expenditure shall be maintained by the B.D.O./ CDO-cum-EOs, ZP concerned. It shall remain open to audit by the authorized auditors and for inspection by the officers of this Department as well as test check by the Accountant General, Odisha, Bhubaneswar and any other agency authorized by the Government for the purpose.
 - (iii) Under no circumstances, funds released shall be utilized for any purpose other than those specified in the instructions issued by PR&DW Department.
 - (iv) The Utilization Certificate of the said grant shall be furnished by the BDOs to CDO-cum-EO, ZPs of the concerned district and the CDO-cum-EO, ZP shall furnish the consolidated U.C. to this Department duly countersigned by the Collector-cum-CEO in the prescribed format of Finance Department.
 - (v) MIS shall be furnished by the CDO-cum-EO, ZP concerned.
 - (vi) No diversion of funds for any other purpose is acceptable and no excess amount beyond the allotment shall be spent.No change of project shall be allowed without assigning proper justification from the competent authority.
