
The CDO-cum-E.O., Zillapaishad, Balasore is requested for release of the said amount in favour of the Executing agencies towards execution of the projects.

You are requested to strictly adhere to the following conditions during execution of the project(s).

1. The revised guidelines under Special Problem Funds (rename as CM-Special Assistance-Mukhyamantri Swatantra Sahayata) and the instructions issued from time to time should be scrupulously followed during execution of the project
2. Funds so released shall not be utilized by way of renovation, restoration or repair of religious institutions constructed unauthorizedly on public places.
3. Funds are to be utilized strictly for the purpose of which it is sanctioned and on no account diversion of fund from one project to another will be made without prior approval of the Govt.
4. Monthly Progress Report on utilization of funds should be furnished (project wise) on or before 3rd of each month.
5. The Assets Register should be maintained at Executing Agency level and the Assets created out of the Grants-in-Aid should not be disposed of without prior approval of Government.
6. The Grant-in-Aid should be utilized during the current financial year.
7. Utilization Certificate should be furnished to the CDO-cum-E.O., Z.P., Balasore under intimation to this office soon after completion of the project(s).
8. The unspent amount / unutilized amount and the left-out amount after completion of the project (if any) should be refunded to CDO-cum-E.O., Z.P., Balasore under intimation to this office.
