In inviting a reference to this Department Resolution No. 6078 dt.26.03.2021 on the subject cited above, I am directed to say that Government have been pleased to approve 1960 no. of projects amounting to Rs. 59,32,99,560/- (Rupees fifty nine crore thirty two lakh ninety nine thousand five hundred sixty) only towards "Maintenance /Improvement of road infrastructure out of MV Tax " under the award of 5th SFC for the F.Y. 2020-21 to F.Y. 2022-23 as enclosed at Annexure-"A".
