Sub: Approval of Project lists towards repair/ restoration of Primary School Buildings, AWCs, GP Buildings & Community Halls and GP/PS Roads damaged due to severe cyclonic storm DANA-2024.

Sir,

In inviting a reference to the above cited subject, I am directed to say that an amount of Rs. 153,09,19,200/- (Rupees one hundred fifty three crores nine lakhs nineteen thousands and two hundred only) has been sanctioned and released for repair/ restoration of Primary School Buildings, AWCs, GP Buildings & Community Halls and GP/PS Roads damaged due to severe cyclonic storm DANA-2024. In respect of Balasore, Bhadrak, Dhenkanal, Jajpur & Mayurbhanj, Districts . The list of approved projects along with abstract (Annexure-A) is enclosed herewith for ready reference.

You are, therefore, requested to take necessary action at your level with following the detail procedure as mentioned below.

1. Estimate for each work against the approved projects will be prepared basing upon the field requirement with due technical sanction by the appropriate authority. The estimate should be released one and if any convergence is required then a separate case record should be opened and the guidelines of that schemes should be strictly followed while executing the Projects.
2. CDO-cum-EO, ZP will communicate the list of detail projects approved by the Government to the BDOs concerned within three days of receipt . Administrative approval will be made by the concerned Block Development Officer.
3. All such work should be executed departmentally and it should be completed within 35 days positively to avoid audit objection both by AG & FD. So, immediate restoration of public infrastructure may be made which has been damaged due to natural calamities.
4. Regular Monitoring and supervision shall be taken up by Collector to ensure timely completion of approved projects.

5. While executing the projects and giving administrative approval to the projects unit cost should be as per extant SDRF/ NDRF guidelines issued by Ministry of Home Affairs.
6. No projects shall be taken up outside the list of projects submitted to SRC and PR & DW Department and duly approved by the Govt. in PR & DW Department.
7. Transparency Board should be installed at each project execution site with 4 feet x 4 feet width 6 inches bride wall with printing in red color over white surface for information of general public.
8. The restoration should be in permanent nature like Cement Concrete Road work in view of the natural calamities faced by the State once in every 2nd year. No other work is permissible in case of road projects and damage of culverts, RCC structures can be taken up under this scheme.
9. The fund so received shall be transmitted to the blocks depending upon the Nos. of projects and amount approved by the Government.
10. Special care should be taken for immediate restoration of AWCs & Primary School Buildings. The concept of built, back and better should be followed.
11. Utilization Certificate should be submitted mentioning the list of projects along with Sanction order No. & date, TV No. & date in the prescribed format issued by the Finance Department.
12. Photographs of each project should be kept in the case record at 3 point of time i.e. before, during & after the completion at the projects.
13. Assessment of the repair/ restoration work of the BDOs shall be considered as one of the parameter while recording remarks in their performance appraisal report in the concerned financial year.
