Sub:- Release of funds for 48 nos of approved projects under CM-Special Assistance (Mukhyamantri Swatantra Sahayata) - 2024-25 (8 th phase).

Sir,

With reference to the subject cited above, I am to say that the Government have been pleased to sanction an amount of Rs.200.00 lakh as against 50 nos projects under CM-Special Assistance (Mukhyamantri Swatantra Sahayata) - 2024-25 (8 th phase) to keonjhar district vide their S.O No 4229 Dt.17.03.25 of P & C Dept.,Odisha, Bhubaneswar. Out of which a sum of Rs.191.00 lakh (One hundred ninety one lakh) only is hereby released for execution 48 nos. projects. You have been selected as the Executing Agencies for execution of the projects as indicated against the name of block/ULB in the enclosed list.

I am directed to request you to implement the projects with strict adherence to the consolidated guidelines of SPECIAL PROBLEM FUNDS issued by the Govt. Planning and Convergence Department letter No. 11449/P dt. 30.9.21 with special focus to the following points.

In case of project is found non-feasible or the location is beyond determination, those should be referred to the undersigned with new proposal for consideration of diversion /substitution by the Collector, Keonjhar with due recommendation of Hon'ble MLA. Change of site or diversion of funds of any project other than the project mentioned in the list should not be done at your level. The project approved shall be implemented as per procedure laid down in consolidated guidelines for utilization of C.M Special Assistance.

2.In Case, the proposed project cost is not within the competence of the concerned Executing Agency to accord Administrative Approval as well as Technical

Sanction, the concerned Executive Agency shall submit the Plan and Estimate with due Technical Sanction from competent authority to this Office for seeking Administrative Approval.

3. The Executive Agencies must ensure that funds are not utilized for repair/construction by way of renovation, restoration and repair of religious institutions constructed unauthorizedly on public places.

4. The Executive Agencies are to verify and ensure feasibility of project, Utility of project for public/Community, availability of non-objection Govt. land and Community land before Issue of work Order. **Besides, the Executing Agency is to certify in the case-record of project under CM-Special Assistance that there is no duplication and this project has not been included under any other existing scheme of any department.**

5. A micro-plan shall be prepared in consultation with all stakeholders for various components to be taken up in respective institutions.

6. The amount sanctioned shall be spent during the current financial year, 2025-26 and utilization certificate be furnished in time.

7. The account shall remain open for Audit both by the Accountant General Odisha as well as the internal Audit of the P & C Deptt.

8. The Executive Agencies shall implement the projects after preparation of P/Es and technical sanction and A/A by competent authorities and submit a copy of the P/E to the undersigned for record.

9. The financial Rules, Procedures and formalities should strictly be followed while executing of the projects.

10. The monthly expenditure statement with status of the project (project wise) must be sent to Deputy Director (P & S) DPMU, Keonjhar for reporting to the Government by 1st week of each succeeding month for which the statement relates. The assets created out of the CM-Special Assistance (Mukhyamantri Swatantra Sahayata) should be handed over to the concerned managing committee/ GP/PS/Department for further upkeep and maintenance.

11. The utilization certificate of the sanctioned funds should be furnished immediately after expenditure is incurred in the prescribed format of Finance Deptt. Odisha to the Zilla Parishad, Keonjhar for adjustment of accounts with Govt./A.G, Odisha.
