
Madam/Sir,

With reference to the subject cited above, I am to inform you that the Collector, Keonjhar has been pleased to approve a total of 271 project proposals (192 projects under the 60% component and 79 projects under the 40% component), amounting to ₹12,62,96,835.00 (Rupees Twelve Crores Sixty-Two Lakhs Ninety-Six Thousand Eight Hundred Thirty-Five only). This includes ₹7,57,78,101.00 under the 60% component and ₹5,05,18,734.00 under the 40% component, in favour of Keonjhar Sadar Block under the Bikashit Gaon Bikshit Odisha (BGBO) scheme for the financial year 2025-26. The utilization of the approved funds is subject to the following terms and conditions:

- The funds shall be utilized strictly as per the guidelines issued by the PR & DW Department vide Letter No. 2298 dated 28.01.2025 and Letter No. 2291 dated 28.01.2025.
- Repetition of projects must be strictly avoided.
- Diversion of funds for any other purpose is not permitted. No excess amount beyond the entitlement for each GP shall be sanctioned or utilized.
- Records must be maintained separately for the 60% and 40% components for reporting purposes.
- Monthly Progress Reports (MPRs) and Utilization Certificates (UCs) must be submitted in a timely manner.
- Prior to issuing work orders, geo-referenced "before execution" photographs must be properly documented and preserved.
- Proper documentation of all projects must be ensured for reporting and audit purposes.

You are, therefore, requested to initiate necessary steps for the timely execution of the approved projects in accordance with the above guidelines.




