SANCTION AND RELEASE ORDER


Release of **Rs.70,45,50,708/- (Rupees Seventy Crore Forty Five Lakhs Fifty Thousands Seven Hundred Eight)** only is hereby accorded as detailed below in favor of the **Block Development Officers** towards implementation / execution of projects under "**Bikashita Gaon Bikashita Odisha (BGBO) scheme for the year 2025-26**". The sanctioned works shall be strictly executed in accordance with the **Guidelines** communicated vide Resolution No.2291 dated 28.01.25, Resolution No. 799 Dated. 07.01.2026, Revised Guideline communicated vide Letter No. 1155 Dated. 09.01.2026 and S.O No. 28051 / 28059 / 28067 Dated. 14-10-2025, 31944 / 31953 / 31961 Dated. 17-11-2025 and 4791 / 4799 / 4807 Dated. 17-02-2026 of PR & DW Department, Odisha and subsequent modification from time to time by Government in PR & DW Department, Odisha, Bhubaneswar.

The following terms and conditions shall be strictly followed while executing the project(s).

1. The above fund shall be utilized as per the Guidelines communicated vide Resolution No.2291 dated 28.01.25, Resolution No. 799 Dated. 07.01.2026, Revised Guideline communicated vide Letter No. 1155 Dated. 09.01.2026 and S.O No. 28051 / 28059 / 28067 Dated. 14-10-2025, 31944 / 31953 / 31961 Dated. 17-11-2025 and 4791 / 4799 / 4807 Dated. 17-02-2026 of PR & DW Department, Odisha.
2. Project with estimated cost of less than Rs. 3.00 lakh shall not be taken up.
3. The project list being recommended by Panchayat Samiti, different public representative and members of civil society duly scrutinized by District Level Committee after receiving feasibility study report from Block Level Team has been approved.
4. Only need based feasible projects shall be taken up on priority.


5. The proposed plan for the Panchayat Samiti is illustrative one but it should not exceed the sanction amount allotted against the Block for each financial year. Any deviation in this regard will attract personal responsibility against the erring officials/officers.
6. In order to maintain transparency in execution of projects, all the projects need to be processed through the BGBO Application and different stages during execution of the project i.e. before start, ongoing and completion, shall be geotagged through mobile app and to be uploaded in BGBO web portal developed by Govt. in PR & DW Department from time to time.
7. All procedures in executing the BGBO schemes should be meticulously followed as laid down on the Resolution No.2291 dated 28.01.25, Resolution No. 799 Dated. 07.01.2026, Revised Guideline communicated vide Letter No. 1155 Dated. 09.01.2026 of PR&DW Department, Odisha and other Circular issued from time to time.
8. All the estimate for the purpose of prescribed works to be taken up as per the model estimate issued by the PR & DW Department, Odisha. No any violation/deviation shall be entertained with.
9. The amount so sanctioned shall be released to the PL account of the BDOs under Scheme ID-145.
10. The Utilization Certificate shall be furnished by the BDOs in the prescribed format (OGFR-23 & 24) to the CDO-cum-EO, Zilla Parishad, Balangir in every quarter and furnish the monthly MIS report about the progress of each work.
11. Under no circumstances, funds released shall be utilized for any purpose other than those specified in the instructions issued by PR & DW Department & guidelines approved by Finance Department.
12. The detailed account of expenditure shall be maintained by the BDOs concerned. It shall remain open to audit by the authorized auditors for inspection by the officers of this Department as well as test check by the Accountant General, Odisha, Bhubaneswar and any other agency authorized by the Government at their discretion.
