2. As per PR&DW Dept. Letter no 2298/ Dt.28.01.2025 the funds will be allocated to GPs by the blocks on the basis of population (as per 2011 Census).
3. The projects with estimated cost less than **Rs. 3.00 Lakh** shall not be taken up under BGBO.
4. The work is to be executed after approval of projects as per guidelines issued by Department from time to time and Convergence Planning be prepared for better execution of projects.
5. The utilization certificate of the said grant shall be furnished by the BDOs to CDO cum-Executive Officer, Zilla Parishad, Puri in the prescribed format (Annexure-VI & VII) of finance Department with in the stipulated time.
6. The detail account of expenditure shall be maintained by the BDOs concerned. It shall remain open to audit by the authorized auditors and for inspection by the officers of this Department as well as check by the Accountant General, Odisha, Bhubaneswar and any other agency authorized by the Government at their Discretion.
7. Under no circumstances, funds released shall be utilized for any purpose other than those specified in the instructions issued by the PR & DW Department and guidelines approved by Finance Department.
