A sum of **Rs. 400000/- ( Four lakh only)** has been sanctioned as intimated by Govt. in PR & DW Deptt, Odisha vide letter No. **39** dtd. **05-01-2026** towards the project namely **CONSTRUCTION OF PAVER BLOCK ROAD AT APOLO SAHI BOREI** GP: **Puttasing** under Scheme **Bikashita Gaon Bikashita Odisha** for the Financial Year **2025-26**.

Accordingly, the (Estimate Creator concerned) of this Block may be instructed to visit the proposed work site, prepare the plan & estimate and submit the same for technical sanction by the appropriate Authority.

This case is instituted upon approval of 77 nos of projects for Rs. 35721082/- (Rupees Three crore fifty seven lakhs twenty one thousand eighty two) only by the Govt in PR & DW Department, Odisha towards the head BGBO for the year 2025-26. The approved list was forwarded by the CDO-cum-EO, Zilla Parishad, Rayagada, vide Letter No. 5525 dated 15.12.2025. But subsequently allotment to the tune of **Rs. 3,57,21,082/-** has been sanctioned vide Sanction & Release Order No. 39 & 40 dated **15.12.2026** of Collector-cum-C.E.O, Zilla Parishad, Rayagada for execution of the projects under "Bikashita Gaon Bikashita Odisha" (BGBO) scheme 1<sup>st</sup> phase (60%) for the year 2025-26. The sanctioned amount has been released to this Block through Treasury PL Cheque. However, in accordance with the allotment received and as per instructions contained in the Sanction Order, the 77 (seventy seven) nos of need-based feasible proposed projects for Rs. 3,57,21,082/- have been selected on priority basis for execution.

The AE/JE of concern GP of this Block has directed to prepare the plan and estimates for the above projects after spot visit of the proposed side to ensure feasibility of the projects and submit the same to the undersigned after due technical sanction of AEE.

In pursuance Rule 73 (b) of Odisha Panchaya Samti Accounting Procedures Rule and as per Govt. of Odisha, PR & DW Department Resolution No. 13220 dated 13.07.2018, all the development work up to Rs. 10.00 lakh shall be taken up departmentally under strict supervision of the AE/JE of the concerned GP and Asst. Executive Engineer of this Block.
