1. The Work should be executed only after lay out is given by the Assistant Executive Engineer concerned and a copy pf plan & estimate duly approve by the undersigned is obtained by you
2. The work should be executed strictly in accordance with the specification in the estimate.
3. The estimate cost of the projects is Rs. ~~20.00~~ ^{200000/-} lakh only from which the following deduction will be made from the bill.
 - A. Work Contingency @ 1% of the estimates cost.
 - B. Cess @ 1% of the estimated cost.
 - C. Security deposit @ 2% of the estimated cost subject to be refunded after necessary audit and receipt of audit report.
4. The work must be completed within 60 days after observing usual for formalities from the date of receipt of this order failing which this order shall stand cancelled without any further intimation.
5. Local labourers should be engaged for execution of the work.
6. The work should be executed under supervision of JE concerned whose instruction shall be binding on you.
7. At the project site a project pillar displaying name of the Scheme, name of the project, estimated cost, etc shall installed before commencement of work.
8. The PR & DW Department shall develop a Web based MIS for monitoring of the intervention. A dedicated app shall be developed for photographs sharing before, during and after for each project with GIS tagging.
9. You will purchase cement of approved companies like ACC, OCL, Ultratech, Konark & JSW from the local market from the authorized stockiest Havin TIN No. The cement bill will be passed at the rate fixed by the PWD at the Executive Engineers level including transportation & GST.
10. Bill will be paid after issue of certificate as to quality & quantity of work by the monitoring Committee constituted for execution of the work.
11. The work order shall ipso facto stand cancelled if any of the terms and conditions outlined herein is violated.
12. The undersigned reserves the right to reject the work order at any time without assigning any reasons thereof.
