3. The approved projects shall be executed as per instructions issued vide this Deptt. Letter No. 14347 Dated 14.09.2020. Convergence planning shall be encouraged for better execution of projects.
4. The approved projects shall be executed by following due procedures and through Panchayatiraj Project Management System (PPMS).
5. The Utilization Certificate of the said grant shall be furnished by the BDOs to CDO-cum-E.O, Z.P of the concerned district and the CDO cum-E.O, Z.P shall furnish the consolidated U.Cs to this Department duly countersigned by the Collector in the prescribed format of Finance Department.
6. The detailed account of expenditure shall be maintained by the BDOs concerned. It shall remain open to audit by the authorized auditors for inspection by the officers of this Department as well as test check by the Accountant General, Odisha, Bhubaneswar and any other agency authorized by the Government at their discretion.
7. Under no circumstances, funds released shall be utilized for any purpose other than those specified in the instructions issued by this Department and guidelines approved by Finance Department.
