

Govt of Odisha Panchayati Raj & Drinking Water Department has approved the project proposals under 5th SFC towards "maintenance of Primary School Buildings" vide letter No 6576 dated 06.04 2021 (Xerox copy enclosed) amounting to Rs.9799360/- out of the previously sanctioned amount 9999360/- vide letter no 19600 dtd 10.12.2020. 


