In pursuance of Govt. of Odisha Panchayatiraj & Drinking Water Department Letter No.5578/ dtd.01.03.25 the projects "Preservation and Development of Water Bodies" under 5th SFC (GIA) for the FY 2024-25 have been approved. Accordingly, a sum of Rs. 13, 27,388/- (Rupees Thirteen lakh twenty seven thousand three hundred eighty eight) only is hereby released in favour of concerned BDOs of the district as per PR & DW Department release Order No. 6250/ PR & DW dated 16.12.2024 (3rd Instalment) as detailed below.

1. The funds shall be utilized as per PR & DW Department Guidelines issued vide letter no.14347 dtd.14.09.2020.
2. No repetition of projects must be ensured.
3. Whenever possible, convergence planning shall be made with MGNREGA, OSR of GP, any other Schematic fund for better execution of works at rural areas.
4. The detailed Account of expenditure shall be maintained by the Block Development Officers concerned. It shall remain open to Audit by authorized Auditors and for inspection by the officers of PR & DW Department as well as test check by the Accountant General, Odisha, Bhubaneswar or any other agency authorized by the govt. for this purpose.
5. No diversion of funds for any other purpose is acceptable and no excess amount beyond the entitled amount against the Block shall be spent.
6. 100% Utilization Certificate for the funds sanctioned in FY 2024-25 shall be submitted to Govt. at the earliest.
7. Work is to be executed out of approved list of projects as per guidelines issued by PR & DW Department from time to time and convergence planning be prepared for better execution of projects.
