5. The detail account of expenditure shall be maintained by the BDOs concerned. It shall remain open to audit by the authorized auditors and for inspection by the officers of this Department as well test check by the Accountant General, Odisha, Bhubaneswar and any other agency authorized by the Government at their Discretion.
