Sub: Sanction of funds for the projects under **CM-Special Assistance (Mukhyamantri Swatantra Sahayata)** during the year **2023-24, 87<sup>th</sup>Phase (Part-I)**

Sir,

With reference to the subject cited above, I am to sanction here with an amounting to **Rs. 9,25,00,000/- (Rupees Nine Crore Twenty Five Lakh Only)** only under CM-Special Assistance for the year **2023-24, 87<sup>th</sup>Phase (Part-I)** for execution of following 326 nos. of projects of Dasarathpur/Korei/Jajpur block areas of Jajpur District.

While executing these projects, the Executing Agency will follow the following points scrupulously.

- 1 The sanctioned projects must be implemented strictly adhering to the prescribed Govt. guidelines under special problem funds communicated to you vide this office letter No. 216/ dt.30.01.2008.
- 2 All the established administrative and financial procedures and modification/instruction issued by the Government from time to time for implementation of development programmes are strictly to be followed during implementation of the sanctioned projects.
- 3 The executing agencies must ensure proper status of the land before the project is executed. As ordered by the Collector, Jajpur the executing agency will ensure that the project is executed on own land of the institution. In no case it is executed on private land. He is personally responsible for any deviation of the Govt. guideline
- 4 The work must be completed in all respect within 120 days. Stipulation of time limit for completion of the work may be made in the work order.
- 5 Separate asset register must be maintained for the scheme at the level of executing agency.
- 6 In case of any unspent balance after completion of the project, the same may be refunded to the CDO-cum-E.O, ZP, Jajpur under intimation to this office.
- 7 The monthly progress report (MPR), project wise should be furnished to this office by 1<sup>st</sup> of each succeeding month.
- 8 Utilization Certificate in duplicate in OGFR No.7 (A) form along with the completion certificate should be furnished to the CDO-cum-E.O, ZP, Jajpur under intimation to this office after completion of the project.
- 9 The Plan & Estimate is prepared for completion of the project in all respect with duely technically sanctioned and administratively approved by the competent authority before execution of work.
- 10 The executing agency will follow the instruction of 5-T of Govt. i.e Transparency, Time, Technology, Team work and Transformation.
- 11 The executing agency will keep the GPS Photographs of the project i.e before execution of work and after completion of project.
