In inviting a reference to the subject cited above, I am directed to say that Government have been pleased to approve 4330 no. of projects amounting to Rs. 114,22,51,634/- (Rupees One Hundred Fourteen Crore Twenty Two Lakh Fifty One Thousand Six Hundred Thirty Four) only towards "Maintenance and Improvement of Road Infrastructure (out of MV Tax)" under the award of 5th SFC (Assignment of Taxes) for the F.Y. 2024-25 as enclosed at Annexure-"A".

The utilization of fund is subject to the following terms and conditions:

1. The Fund allotted shall be utilized as per the guidelines issued by this Department vide letter No.14347, dtd- 14.09.2020 and No. 13477 dt.24.06.2024.
2. Non-Repitition of project must be ensured.
3. No diversion of funds for any other purpose is acceptable and no excess amount beyond the entitled amount against the Block shall be spent.
4. Wherever possible, convergence planning shall be made with MGNREGA, OSR of GP, any other Schematic fund for better execution of works at rural areas.

Therefore, you are requested to take necessary steps towards early execution of the approved projects and submission of utilization certificate to this Department.
