- ii) The detailed Account of Expenditure shall be maintained by the Executing Agency. It shall remain open to the Audit by authorized Auditor and for inspection by the Officers of this Office/Deptt. as well as test check by the Accountant General, Odisha, Bhubaneswar or any other agency authorized by this office/Government for the purpose.
 - iii) Under no circumstances, Funds released shall be utilized for any purpose other than those specified in the above.
 - iv) No diversion of funds for any other purpose is acceptable and no excess amount beyond the allotment shall be spent. No change of project shall be allowed without assigning proper justification and approval of the competent authority.
 - v) **The monthly expenditure statement & MPR/QPR indicating physical and financial achievement should be furnished to the Deputy Director(P&S), DPMU, Nabarangpur with a copy to the office of CDO-cum-EO, ZP, Nabarangpur.**
 - vi) The Asset Register should be created and assets so created out of the Grant-in-Aid should not be disposed of without approval of the Government.
 - vii) Utilization Certificate in duplicate signed by the Executing Agency shall be furnished to the undersigned in respect of funds sanctioned and released to the approved project "Special Problem Funds, renamed CM- Special Assistance (Mukhyamantri Swatantra Sahayata for the year 2024-2025 citing S.O. No., T.V. No. & Date of drawl with project lists (physical achievement).
 - viii) Executive Agency concerned will furnish a certificate to the Plan & Estimate with an effect that the project approved under project "Special Problem Funds, renamed CM- Special Assistance (Mukhyamantri Swatantra Sahayata , 2024-2025 does not overlap with works of similar nature under any scheme and no duplication at Central/state external assistance to the project.
 - ix) Feasibility report of each project must be submitted along with Plan & Estimate.
 - x) **Executive Agencies are directed to strictly adhere the above points without any deviation.**
