In inviting a reference to the subject cited above, I am directed to say that Government have been pleased to approve 4336 no of projects amounting to Rs. 114,22,51,634/- (Rupees One Hundred Fourteen Crore Twenty Two Lakh Fifty One Thousand Six Hundred Thirty Four) only towards "Maintenance and Improvement of Road Infrastructure (out of MV Tax)" under the award of 5th SFC (Assignment of Taxes) for the F.Y.2024-25 as enclosed at Annexure-"A".

4. Wherever possible, convergence planning shall be made with MGNREGA, OSR of GP, any other Schematic fund for better execution of works at rural areas.

Therefore, you are requested to take necessary steps towards early execution of the approved projects and submission of utilization certificate to this Department.


