

**PROCEEDING OF THE MEETING OF DISTRICT LEVEL COMMITTEE ON
BIKASHITA GAON BIKASHITA ODISHA (BGBO) HELD ON 11.02.2026 AT
ZILLA PARISHAD CONFERENCE HALL, KANHAMAL, PHULBANI.**

The meeting of the District Level Committee (DLC) for finalization of projects under "Bikashita Gaon Bikashita Odisha (BGBO)" was held on 11.02.2026 at 04.00 PM under the Chairmanship of the Collector-cum-CEO, Zilla Parishad, Kandhamal.

The list of officers present in the meeting is enclosed at Annexure-A.

At the outset, the CDO-cum-EO, Zilla Parishad, Kandhamal welcomed the Chairman, DLC, BGBO and other members/officers present in the meeting. He apprised the Committee about the BGBO Guidelines issued by the PR & DW Department, Odisha, vide Letter No. 1155 dated 09.01.2026. In pursuance of the aforesaid comprehensive BGBO Guidelines, the Collector-cum-CEO, Zilla Parishad, Kandhamal and Chairman, DLC, BGBO issued a public notice inviting proposals vide Notice No. 93 dated 09.01.2026.

As per the Notice No. 93 dated 09.01.2026, project proposals were invited from elected representatives, civil society organizations, and the general public up to 17.01.2026. The notice was widely published through the Notice Boards of the Collectorate, Zilla Parishad Office, and all Block and Gram Panchayat offices of Kandhamal District, and was also uploaded on the District Web Portal.

Project proposals were received at the District, Block, and Gram Panchayat levels within the prescribed timeframe. In view of the large number of proposals received from various sources, it is difficult for the District Level Committee to verify the admissibility and feasibility of each project proposal. Hence, the District Level Committee decided that the admissibility and feasibility of the projects received from the Gram Sabha and all proposals received pursuant to the notice issued by the Collector, as per Para 7.2 of the BGBO Comprehensive Guidelines issued by the PR & DW Department, Government of Odisha, vide Letter No. 1155 dated 09.01.2026, shall be scrutinized at the Block level by the concerned BDOs and their technical teams.


After detailed scrutiny at the Block level, the BDOs submitted the project proposals to the District Level Committee after examining their feasibility, admissibility, and financial allocation for further consideration and approval.


The District Level Committee examined and verified the project proposals submitted by the BDOs and found them to be in order, in conformity with the approved financial allocation and BGBO Guidelines. The final list of projects (Block-wise abstract), as approved after scrutiny by the District Level Committee, is as follows:

The meeting ended with a vote of thanks to the Chair.


