The following procedures may also be adhered during execution of these projects.

- ❖ The amount hereby sanctioned shall be utilized during the current financial year 2025-26.
- ❖ The fund shall be utilized as per guideline and instructions issued under BGBO scheme from time to time by PR Department.
- ❖ Under No circumstances funds released shall be utilized for any purpose other than those specified in the instructions issued by the PR Department and guideline approved by finance Department.
- ❖ The work is to be execute after approval of projects as per guidelines issued by department from time to time.
- ❖ No diversion of funds for any other purpose is acceptable and no excess amount beyond the allotment shall be spent. No change of project shall be allowed without assigning proper justification from the competent Authority.
- ❖ The Plan & Estimate of the sanctioned projects duly technically sanctioned and administratively approved by the competent authorities before execution of the project.
- ❖ Balance amount if any after completion of the project may be refunded to the Zilla Parishad, Gajapati .
- ❖ The account shall remain open for audit both by the Accountant General Odisha as well as the internal audit of the PR & DW Deptt.

- ❖ The asset register should be created and assets so created out of Grant-in-aid should not be disposed of without approval of Government.
- ❖ The MPR & QPR indicating physical and financial achievement should be furnished regularly to the Zilla Parishad, Gajapati by the end of 1<sup>st</sup> week of every month.
- ❖ The Utilization Certificate in triplicate should be furnished on O.G.F.R. No. 7 (A) form immediately after completion of the project to the CDO-cum-Executive Officer, Zilla Parishad, Gajapati .
