SANCTION ORDER

Sanction is hereby accorded for release of an amount of Rs. **129836644/-** (Rupees twelve crore ninty-eight lakh thirty-six thousand six hundred forty-four) only in favour of Block Development Officers of Sambalpur District under "Bikashita Gaon Bikashita Odisha (BGBO) scheme for the year 2025-26.

4. Under no circumstances, fund released shall be utilized for any purpose other than those specified in the instruction issued by PR & DW Department and Guideline approved by the Finance Department.


