
1. Total above funds shall be utilized as per the department Resolution No. 2291 Dated 28.01.2025.

3. The work is to be executed after approval of projects as per guideline issued by departments from time to time and conversance planning be prepared for better execution of projects.
4. No diversion of funds for any other purpose is acceptable and no excess amount beyond the allotment.
5. Fund shall be utilised on the basis of the population of the block and GP respectively.
6. No Pro-rata charges are applicable in case of Departmental execution of works.
7. The Panchayat Samiti shall execute the works as per Panchayat Samiti Rules, 2022 and subsequent amendment therein from time to time.
8. Provision of OPWD Code shall be followed for execution of works.
9. The Utilisation certificate of the said grant shall be furnished by the BDOs to the CDO-cum-EO, Zilla Parishad, Koraput duly countersigned by the Chairpersons of the concerned blocks.
